Miami-Dade County Commissioners will conduct budget hearings on Thursdays, Sept. 3 and 17, at 5:01 p.m., in the Commission Chambers (second floor) of the Stephen P. Clark Government Center, 111 NW First St. in downtown Miami, to allow for citizen input in the FY 2009-10 county budget process.

To participate, anyone wishing to speak must register with the office of the agenda coordinator at least 15 minutes prior to the start of the budget hearing. Directional signs will be set up on the first floor pointing to a registration table where people can sign up to speak.
